If the repeater is not in "Net Mode" automatically, press PTT button and press 991 to turn it on.

This is [call sign] asking all stations to please stand by for the Brightleaf Amateur Radio Club net.

[Pause]

Good evening, this is [call sign], Net Control for the *Brightleaf Amateur Radio Club Net*. My name is [name] and my location is *Greenville [city name]*.

The Brightleaf Amateur Radio Club net meets each Monday night at 2000 hours local time for the purposes of planning, practicing and discussing the activities of *Brightleaf Amateur Radio Club*. When the business portion of the net is over, there will be a rag chew session.

This net operates on the W4GDF repeater located in Greenville, NC, using frequency 147.090 MHz. Please note that this repeater requires a sub-audible tone of 131.8. In case of repeater failure, the net will continue on 147.090 MHz simplex.

Emergency traffic receives top priority during this net. If you have an emergency, please call Net Control at any time with your call sign and state that you have emergency traffic. [Pause]

This is a directed ARRL affiliated net. Please transmit only at the direction of Net Control. You do not need to be a member of *Brightleaf Amateur Radio Club* to participate in this net.

We will now stand by for check-ins. Stations are asked to check in alphabetically according to the first letter of your call suffix. This is the first letter following the number in your call sign.

When checking in, please give your call sign stated phonetically, followed by your name and location. Announcements and Traffic, both formal and informal should be listed when checking in. However, informal traffic will not take place until after the net has closed. [Pause]

Check-ins: [Log them on *BARC-NetLog-Worksheet*]

Now taking check-ins from any mobile, short-time, or EchoLink stations. Mobile, short-time, or EchoLink stations only, please call Net Control. [Pause and let repeater carrier drop for at least 5 seconds to allow for EchoLink check-ins]

Stations ALPHA through GOLF, ALPHA through GOLF, please call Net Control. [Pause]

Stations HOTEL through SIERRA, HOTEL through SIERRA, please call Net Control. [Pause]

Stations TANGO through ZULU, TANGO through ZULU, please call Net Control. [Pause]

This is [Call Sign] with Brightleaf Amateur Radio Club net. Are there any additional check-ins for the net – ALPHA through ZULU, please call Net Control [Pause] [Any formal traffic should be passed at this time]

Announcements:

[Recognize Calls with announcements listed during roll call, one at a time.] [Pause]

Are there any announcements not previously listed? If so, please call Net Control. [Pause]

Formal Session:

Ragchew Session:

Call stations for their Ragchew in the following order:

- Mobile, short-time, or EchoLink stations in the order they checked in.
- Fixed stations in the order they checked in.

About half way through the Ragchew roster, make a call for additional check-ins, Alpha through Zulu. After completing the Ragchew roster, make another call for additional check-ins, Alpha through Zulu.
